TIME TO RENEW YOUR AAUW MEMBERSHIP

WOMEN GRADUATES-USA

It's been an exciting month for the WG-USA organization, topped by the recent 62nd Commission on the Status of Women [CSW62] Session held at the United Nations Headquarters in NY City.

WG-USA presented "Intersecting Grassroots Radio and New Technologies to Reach Rural and Refugee Women." Louise McLeod gave a comprehensive presentation on global women's educational opportunities and empowerment through connected mobile phone access. She stated that over 6 billion people have access to mobile phones while only 4.5 billion have access to toilets. Other presentations included co-sponsoring the Nonviolent Peaceforce presentation: "Preventing Gender-Based Violence In Rural South Sudan" and "Human Trafficking and CEDAW: Meeting Challenges and Utilizing Opportunities" co-sponsored with the United Nations Association of the United States of America.

Advocacy in Action



The AAUW National Board of Directors has voted to put three proposals for bylaws amendments before the membership for a vote this spring. The Board strongly supports the proposed amendments and we believe this will help keep AAUW vital as an organization.

Proposal 1- Staggered Terms of Office

A staggered term refers to the practice in which members of a board of directors are not up for election at the same time. Following review of nonprofit board governance trends and best practices, and discussion of the possible benefits of staggered-term model could bring AAUW. **AAUW recommends we move to three-year staggered terms.**

Proposal 2- Membership Requirement for AAUW Board of Directors

AAUW is undergoing an important strategic planning process. In planning discussions, it has become apparent that we need to open our board to people who may not be members of AAUW but bring a wealth of experience and expertise to our organization. Should this amendment be approved by the membership, it would allow those who are not currently AAUW members to serve if elected in board leadership.

Proposal 3- Degree Requirement for AAUW membership

AAUW has always been dedicated to breaking down barriers that prevent women from achieving their goals and it is important that AAUW recognize the power of welcoming anyone who supports our mission. AAUW cannot promote equity for all women and girls if the organization maintains exclusionary membership requirements. In addition, eliminating the membership requirement will promote a more inclusive and diverse membership.


THINKING OF YOU...

Of Note... What You Should Know about Equal Pay Policy and the Gender Pay Gap

The gender pay gap is a primary issue for AAUW and one that we have been working on for years. As early as 1922, AAUW's legislative program called for a reclassification of the U.S. Civil Service and repeal of salary restrictions in the Women's Bureau. In 1955, AAUW supported a bill introduced by Reps. Edith Green (D-OR) and Edith Rogers (R-MA) requiring "equal pay for work of comparable value requiring comparable skills." Congress finally



enacted the Equal Pay Act, a version of the 1955 bill, in 1963.

Despite the Equal Pay Act, the gender pay gap persists; women

are typically paid just 80 cents for every dollar paid to men - and that number has barely budged in a decade. Although enforcement of the Equal Pay Act and other civil rights laws has helped to narrow the gender pay gap, these actions only cover segments of the American working population, and many important protections are not yet codified in law. Moreover, there are numerous other reasons for discrimination and pay disparity that must be addressed.

AAUW continues to advocate for strong pay equity legislation, regulation, and enforcement to protect employees and assist employers. Equal Pay Day is an opportunity to draw attention to the gender pay gap and to call for legislative action and other solutions, including AAUW's salary negotiation workshops, to curb this pervasive problem.

Think 80 cents is bad? The pay gap is even worse for some women of color. AAUW also observes equal pay days throughout the year focusing on Asian American, African American, Native American, and Latina women. - 2018 Equal Pay Days:

February 22, 2018- Asian American women's Equal Pay Day April 10, 2018 - All women's Equal Pay Day April 17, 2018 - White women's Equal Pay Day August 7, 2018 - Black women's Equal Pay Day September 27, 2018 - Native women's Equal Pay Day November 1, 2018 - Latinas' Equal Pay Day

LC Bulletin Recognizes Megan McQueen


